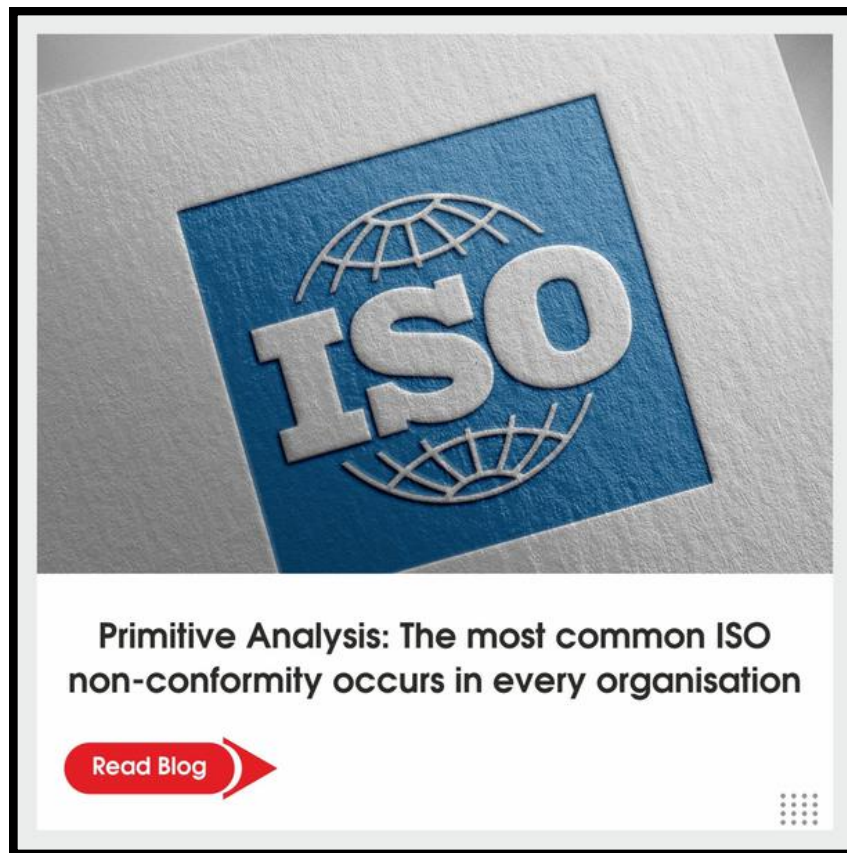

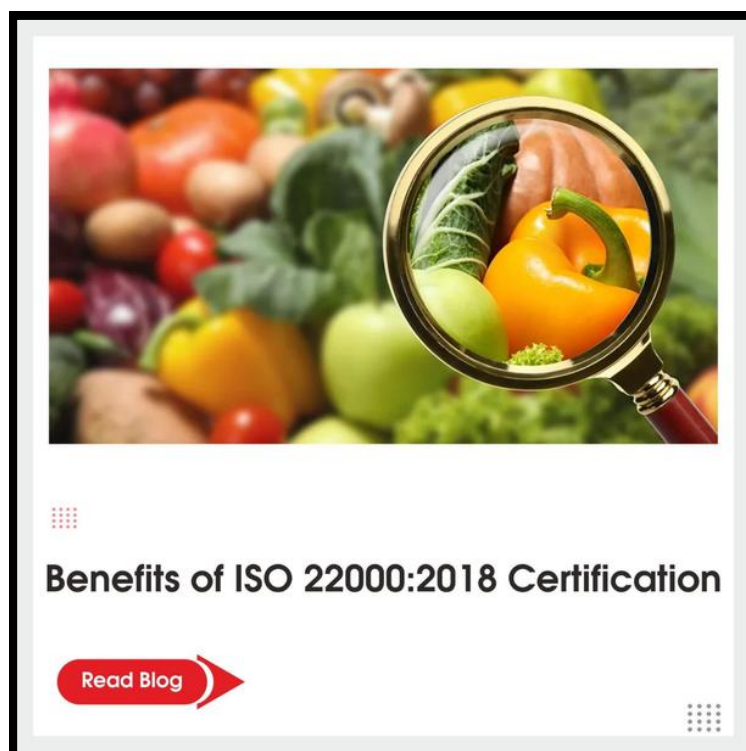

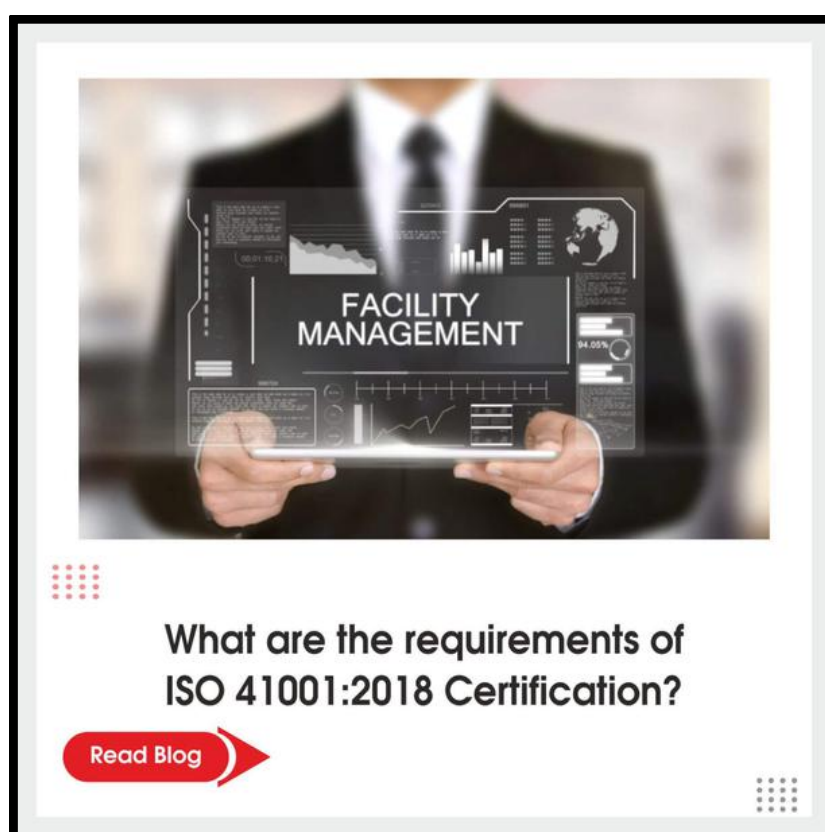
## Benefits of ISO 22000:2018 Certification

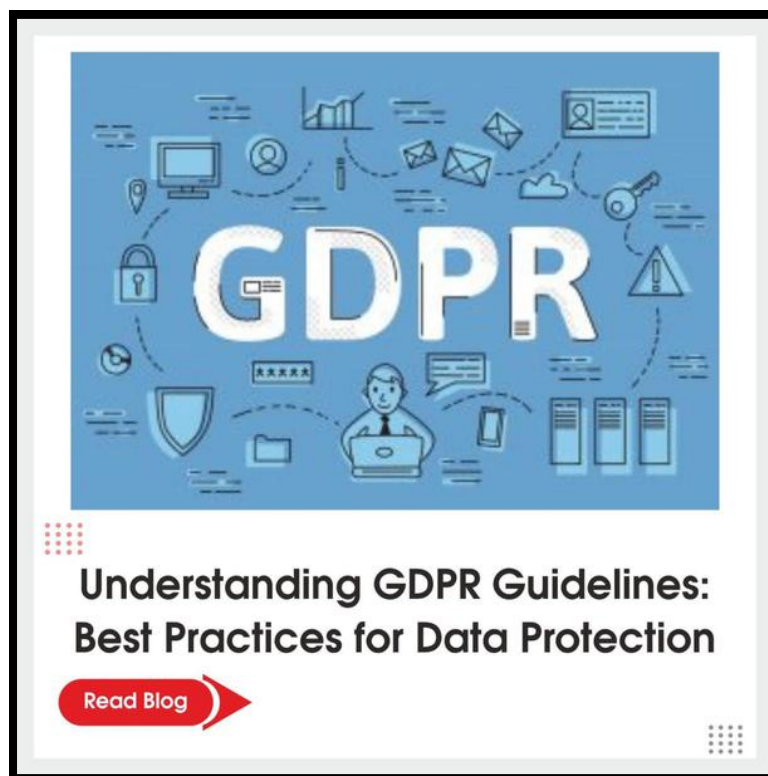
## What are the requirements of ISO 41001:2018 Certification?
